#### MISSION STATEMENT

The Carpet Cushion Council is dedicated to promoting the use of better quality carpet cushion in all markets in which its members operate – primarily the residential and commercial carpet markets. The Council also works to increase trade awareness of the value and benefits of quality carpet cushion.

The Council also acts as the industry representative in matters relating to the Department of Housing and Urban Development (HUD), the Environmental Protection Agency (EPA) and other federal, state and local regulatory bodies.

- ✓ Discounted participation fee for Green Label Plus (GLP) certification, which is the leading indoor air quality environmental program for Carpet Cushion. CCC administers the program; Technical Manager communicates test results to participants, offering explanations for the emission of specific chemical substances; Member discount averages \$4,700 per year
- ✓ Twice yearly meetings where members hear from outside experts, and receive detailed updates on regulatory and technical issues impacting the industry. Meetings also provide an opportunity for Manufacturing Members to interact with Associate (Supplier) Members
- ✓ Opportunity to participate in, and have access to the data resulting from various industry cushion testing and other environmental, safety and healthrelated technical studies.

# ANNUAL DUES STRUCTURE Effective January 1. 2024

#### **Manufacturing Members**

Up to 1 million square yards of sales per year

\$2,500

Plus \$0.00075 per square yard sold per year on all square yards over 1 million

Maximum dues payment of \$25,000

#### **Associate Members**

Net dollar sales into the separate cushion industry in the preceding year, including that estimated to produce scrap which is used to make bonded underlay

Up to \$2.5 million	\$2,500
Up to \$5 million	\$3,750
Up to \$10 million	\$5,700
Up to \$15 million	\$7,500
More than \$15 million	\$18,000

Dues invoices for the upcoming year are to be sent to members on December 1 of each year, payable on February 1 of the following year.

For Manufacturing Members, dues are to be calculated on the number of square yards shipped in the year ending June 30 of the previous year.

For Associate Members, dues are to be calculated on dollar sales to the industry for the year ending September 30 of the previous year.

For International Members, not selling cushion in the U.S., dues will be \$2,000.
